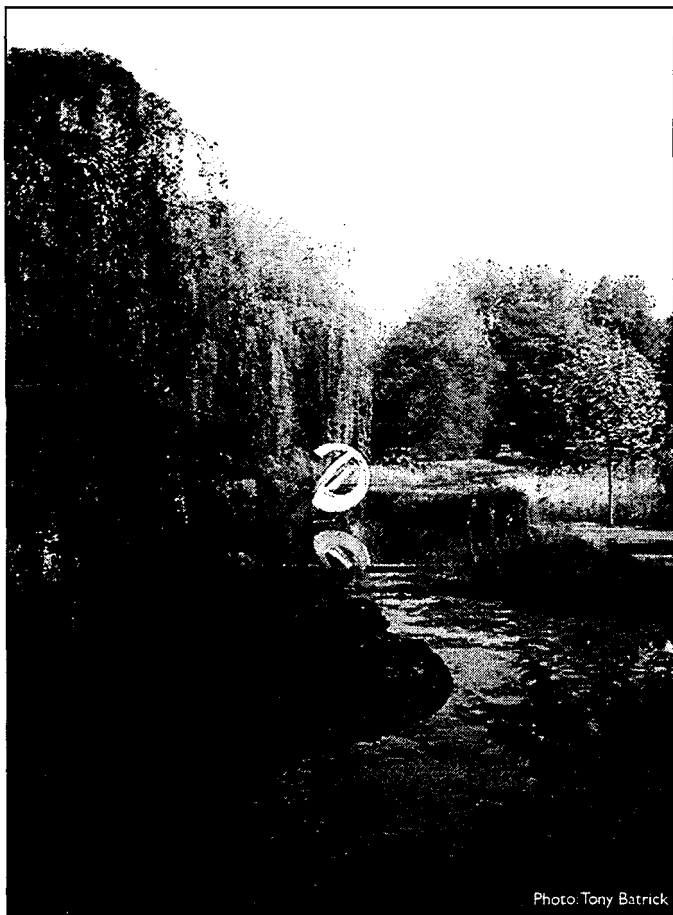

Of course we all recognise that the council has no option but to develop some areas of the town, but it would be pure vandalism for it to continue to take the easy option and steal YET MORE of our most precious park! ## Cuts "no cause for concern"

EIGHT members of the TPUG met with Doug Patterson, Harlow Council's Chief Executive, at the Town Hall on March 14. Concerns were raised that a 10 per cent cut in the Parks and Landscapes budget and proposed job losses among grounds maintenance staff would seriously impact on future work in the park. Mr Patterson said the decision to slash spending by €360,000 a year was a regrettable but necessary one, assuring members that no detrimental effects would be felt as a consequence.

# Orienteering Course Launch

There is now a revamped Permanent Orienteering Course in Harlow Town Park. It is open to anyone of any age and can be enjoyed at any level of fitness or experience, from the complete beginner to the experienced orienteer. You can cover the course at any time, at any speed, in any order, on your own or with friends or relations. No equipment is necessary, other than a pen or pencil – all you need to do is to buy a map-pack from either the Sportcentre, the Swimming Pool, Harlow Outdoor Pursuits Centre, or Spurriers Cafe. The cost is €1 and includes a simple instruction sheet which has a grid to fill in with the letters you find at each checkpoint.

At 11:00am on Saturday June 8 the course will be officially opened by Noel Thatcher MBE, Harlow's Gold Medal winning Paralympic athlete. On this day only, map-packs will be on sale in the School Lane car park, near the Greyhound pub, from 10:30am until 12:00pm.

TEN-17 radio will be there, as will the local papers.

A special type of orienteering event, called a "score event", will also be available from 11:00am onwards. Each point on the course, or "control", will be worth a certain number of points, and the aim of the event is to score as many points as possible in 45 minutes. The top three in each age group (up to 11, 12-18, 19-45, 46 and over) will be announced on TEN-17 and in the local papers. Children under 10 must be accompanied by an adult. You can start at any time from 11:00am to 12:00 midday.

Pets Corner's Essex Pig herd has grown following the purchase of two more gilts as companions for Fergie.

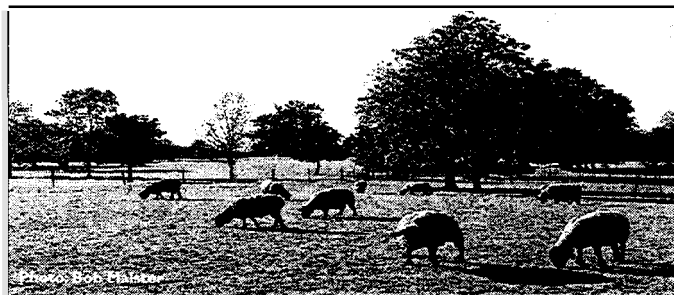
Since the lifting of the restrictions imposed during last year's outbreak of foot and mouth disease, it is good to report the return of more volunteer staff to Pets Corner.

## "Free Market" Gardeners?

At the last TPUC meeting on May 9, we were informed of the devastating cuts which are to be imposed on the Parks and Landscapes Department.

Undoubtedly, such cuts can only lead to an inferior service. Yet, interestingly, this meeting immediately followed the local council elections in which all of the parties pledged in their manifestos to "protect green spaces".

To obviate the effects of these cuts town-wide, some green spaces will be tended by local residents as an extension of their gardens, some areas will be left to grow and then be cut by farmers, and many areas will be changed to more manageable plants or simply grassed over.



This, however, is less of a problem than the proposed cut in the workforce and reliance upon temporary employment in the summer months. The experience and knowledge gained through many years of employment with the council will quite literally be thrown away, as many committed frontline staff are faced with redundancy, and much of the responsibility for the upkeep of our park is handed over to an unknown quantity in

the shape of inexperienced casual contractors.

Such a move marks a significant shift to a privatised workforce under which standards will fall. At the same time, apparently in order to make the remaining workforce "more efficient", there will have to be some considerable investment in new machinery. Surely the finance for the purchase and maintenance of expensive new tractors and other equipment would be better spent on maintaining our existing highly skilled and experienced team of gardeners?

Finally, we are told that even this is an interim proposal, as within the next five years the council will be seeking "partnership" to provide the service. This is another way of saying that someone else will do the work, someone unelected by us, someone who is not accountable through our local democracy. As such, it marks a further shift away from public provision in the Parks and Landscapes Service towards total privatisation.

Our park faces the prospect of being vandalised by these proposals and residents should re-awaken the spirit of the HOOP campaign and let the new councillors hear their voice of disapproval.
